



ORDER UNDER SECTION 14 OF THE COMMISSIONS OF INQUIRY ACT 1995 (TAS)

Date of order: 18 August 2022

THE COMMISSION NOTES THAT:

- A. By order dated 15 March 2021, Her Excellency Professor The Honourable Kate Warner AC established the Commission of Inquiry into the Tasmanian Government's Response to Child Sexual Abuse in Institutional Settings (**Commission**) under section 4 of the *Commissions of Inquiry Act 1995* (Tas) (**Act**).¹
- B. In making this Order, the Commission is satisfied under section 14(1) of the Act that any public interest in the reporting of the hearing or publishing of the evidence set out in this Order is outweighed by other relevant considerations, namely the privacy of personal affairs.

THE COMMISSION ORDERS THAT:

- 1 Under section 14(1) of the Act, any information or evidence given to the Commission during the hearings between Thursday, 18 August 2022 and Friday, 26 August 2022 (**Hearings**) which may identify the individuals:
- (a) giving evidence who are to be known as:
 - (i) 'Simon';

is not to be published other than in accordance with the Commission's directions and to:
 - (c) 'Simon', 'Warren', 'Jane', 'Eve', 'Alysha', 'Max', 'Fred', 'Erin' and 'Charlotte' (respectively) and any Counsel or solicitors retained by them in relation to the Hearings;
 - (d) any person providing support to 'Simon', 'Warren', 'Jane', 'Eve', 'Alysha', 'Max', 'Fred', 'Erin' or 'Charlotte' during the Hearings;
 - (e) the State of Tasmania, and any Counsel and solicitors retained by the State;
